# 1 Public Hearing on proposed 2007 Ad Valorem Tax Rate for Texas Southmost College District

He reported that the Board is proposing a maintenance and operation tax rate of \$0.111423 and a debt tax rate of \$0.049666 for a total tax rate of \$0.161089 per \$100 valuation. Mr. Gonzalez noted that the notice of the public hearing was published in The Brownsville Herald and The Valley Morning Star on Monday, August 13, 2007.

Mr. Dagoberto Barrera, a community member, addressed the Board regarding the proposed 2007 tax rate. There were no other speakers.

Mr. Gonzalez announced that there will be another Public Hearing on Thursday, August 23, 2007 at 5:30 p.m. in the Gorgas Board Room. The regular Board Meeting to vote on the tax rate is scheduled for Thursday, August 30, 2007 at 5:30 p.m. at the Board Room, Gorgas Hall, Texas Southmost College.
